The May 23, 2018 meeting of the Wildlife Resources Committee was called to order by Chairman Dee Yancey.

Chairman Yancey called on John Bowers, Chief of Game Management.

Mr. Bowers stated that Item A was an action item pertaining to proposed amendments to hunting regulations in regards to migratory bird regulations.

<u>A motion was made by Mr. Hatfield, seconded by Mr. Mobley, and carried unanimously that the</u> <u>Board adopt the proposed amendments to hunting regulations, chapter 391-4-2, pertaining to migratory</u> <u>bird regulations, as presented.</u>

Mr. Bowers stated that Item B was an action item pertaining to proposed amendments to hunting regulations for WMAs and other state lands.
